SENATE BILL NO. 13

AN ACT TO AMEND TITLES 12 AND 25 OF THE DELAWARE CODE RELATING TO ABANDONED OR
UNCLAIMED PROPERTY.

1 WHEREAS, an effectively functioning unclaimed property program has long been and remains a vital component
2 of the State's consumer protection regime; and

3 WHEREAS, through its unclaimed property program, the State has, since 2013, returned more than \$300 million
4 in cash and securities to rightful owners; and

5 WHEREAS, the State's continued ability to reunite owners with their unclaimed property relies first on the
6 compliance among holders of such property with the State's unclaimed property statute; and

7 WHEREAS, ensuring continued proper compliance among holders requires that the State has effective
8 enforcement mechanisms that are predictable and even-handed in their application; and

9 WHEREAS, there have been significant technological developments in the State's ability to efficiently interact
10 with holders and consumers in the reporting and claims processes; and

11 WHEREAS, the substance of the State's unclaimed property law has for decades served well the State's citizens;
12 and

13 WHEREAS, solely for ease of administration and organizational clarity, existing subchapters should be struck in
14 their entirety and the statute restructured in a more orderly manner; and

15 WHEREAS, it is critical to preserve the valuable longstanding elements of the State's unclaimed property law
16 while updating other elements necessary to address contemporary conditions.

17 NOW, THEREFORE:

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

19 Section 1. Amend § 1102, Title 12 of the Delaware Code by making deletions as shown by strike through and
20 insertions as shown by underline as follows:

21 § 1102. Escheator of the State.

22 There shall be an Escheator of the State, who shall be the Secretary of Finance or the Secretary's delegate. The
23 administration and enforcement of this ~~subchapter~~ chapter are vested in the Secretary of Finance or the Secretary's
24 delegate.

25 Section 2. Amend Subchapters II, III, and IV of Chapter 11, Title 12 of the Delaware Code by deleting these
26 Subchapters in their entirety and by making deletions as shown by strike through and insertions as shown by underline as
27 follows:

28 Subchapter II. Unclaimed Property.

29 § 1130. Definitions.

30 As used in this chapter:

31 (1) “Audit Manager” means the Abandoned Property Audit Manager of the Delaware Department of Finance.

32 (2) “Banking organization” includes any organization, corporation, or association organized and existing
33 under Chapter 7, 15, or 17 of Title 5 or the corresponding provisions of statutes in effect prior to February 12, 1953, or
34 any bank or credit union created under the laws of the United States or any state.

35 (3) “Business association” means a for profit or nonprofit corporation, joint stock company, investment
36 company, partnership, unincorporated association, joint venture, limited liability company, business trust, trust
37 company, land bank, safe deposit company, safekeeping depository, financial organization, insurance company,
38 federally chartered entity, utility, sole proprietorship, or other business entity.

39 (4) “Domicile” means as follows:

40 a. For a corporation, the state of its incorporation.

41 b. For a business association, other than a corporation, whose formation or organization requires a filing
42 with a state, the state of its filing.

43 c. For a federally chartered entity, the state of its home office.

44 (5) “Electronic” means relating to technology having electrical, digital, magnetic, wireless, optical,
45 electromagnetic, or similar capabilities.

46 (6) “Financial organization” means a savings and loan association, building and loan association, savings
47 bank, industrial bank, bank, banking organization, or credit union.

48 (7) “General Fund” means the General Fund described in § 6102 of Title 29.

49 (8) “Gift card” means a record that may be used to obtain merchandise, goods, or services at a single retailer
50 of goods or services or an affiliated group of retailers of goods or services.

51 (9) “Holder” means any person having possession, custody, or control of the property of another person and

52 includes a post office, a depository, a bailee, a trustee, a receiver or other liquidating officer, a fiduciary, a
53 governmental department, institution or agency, a municipal corporation and the fiscal officers thereof, a public utility,
54 service corporation, and every other legal entity incorporated or created under the laws of this State or doing business
55 in this State. For purposes of this chapter, the issuer of any intangible ownership interest in a corporation, whether or
56 not represented by a stock certificate, which is registered on stock transfer or other like books of the issuer or its agent,
57 is a holder of such property. This definition shall be construed as distinguishing the term “holder” of property from the
58 term “owner” of property, as “owner” is defined in this section, and as excluding from the term “holder” any person
59 holding or possessing property by virtue of title or ownership.

60 (10) “Insurance company” means an association, corporation, or fraternal or mutual-benefit organization,
61 whether or not for profit, engaged in the business of providing life endowments, annuities, or insurance, including
62 accident, burial, casualty, credit-life, contract-performance, dental, disability, fidelity, fire, health, hospitalization,
63 illness, life, malpractice, marine, mortgage, surety, wage-protection, and worker-compensation insurance.

64 (11) “Loyalty card” means a record given without direct monetary consideration under an award, reward,
65 benefit, loyalty, incentive, rebate, or promotional program that may be used or redeemed only to obtain goods or
66 services or a discount on goods or services. The term does not include a record that may be redeemed for money or
67 otherwise monetized by the issuer.

68 (12) “Mineral” means gas, oil, coal, oil shale, other gaseous liquid or solid hydrocarbon, cement material,
69 sand and gravel, road material, building stone, chemical raw material, gemstone, fissionable and nonfissionable ores,
70 colloidal and other clay, steam and other geothermal resources, and any other substance defined as a mineral by law of
71 this State other than this chapter.

72 (13) “Mineral proceeds” means an amount payable for extraction, production, or sale of minerals, or, on the
73 abandonment of the amount, the amount that becomes payable after abandonment. The term includes an amount
74 payable as follows:

75 a. For the acquisition and retention of a mineral lease, including a bonus, royalty, compensatory royalty,
76 shut-in royalty, minimum royalty, and delay rental.

77 b. For the extraction, production, or sale of minerals, including a net revenue interest, royalty, overriding
78 royalty, extraction payment, and production payment.

79 c. Under an agreement or option, including a joint operating agreement, unit agreement, pooling
80 agreement, and farm out agreement.

81 (14) “Municipal bond” means a bond or evidence of indebtedness issued by a municipality or other political

82 subdivision of a state.

83 (15) "Net card value" means the original purchase price or original issued value of a stored-value card, plus
84 amounts added to its original value and minus amounts used by the owner.

85 (16) "Non-freely transferable security" means a security that cannot be delivered to the State Escheator by the
86 Depository Trust Clearing Corporation or a similar custodian of securities providing post-trade clearing and settlement
87 services to financial markets or cannot be delivered because there is no agent to effect transfer. The term includes a
88 worthless security.

89 (17) "Owner" means a person, or the person's legal representative when acting on behalf of the person, that
90 has a legal, beneficial, or equitable interest in property subject to this chapter. The term includes all of the following:

91 a. A depositor, for a deposit.

92 b. A beneficiary, for a trust other than a deposit in trust.

93 c. A creditor, claimant, or payee, for other property.

94 d. The lawful bearer of a record that may be used to obtain money, a reward, or a thing of value.

95 (18) "Person" means an individual; estate; business association; public corporation; government or
96 governmental subdivision, agency, or instrumentality; or other legal entity.

97 (19) "Property" means tangible property described in § 1134 of this title or a fixed and certain interest in
98 intangible property held, issued, or owed in the course of a holder's business or by a government, governmental
99 subdivision, agency, or instrumentality. The term:

100 a. Includes all income from or increments to the property.

101 b. Includes property referred to as or evidenced by any of the following:

102 1. Money, virtual currency, interest, dividend, a check, draft, or deposit.

103 2. A credit balance, customer's overpayment, gift card, stored-value card, security deposit, refund,
104 credit memorandum, unpaid wage, unused ticket for which the issuer has an obligation to provide a refund,
105 pari-mutuel ticket, mineral proceeds, or unidentified remittance.

106 3. A security, bond, debenture, note, or other evidence of indebtedness.

107 4. Money deposited to redeem a security, make a distribution, or pay a dividend.

108 5. An amount due and payable under the terms of an annuity contract or insurance policy.

109 6. An amount distributable from a trust or custodial fund established under a plan to provide health,
110 welfare, pension, vacation, severance, retirement, death, stock purchase, profit-sharing, employee-savings,
111 supplemental-unemployment insurance, or similar benefits.

112 c. Does not include any of the following:

113 1. “Uninvoiced payables,” as defined in this section. Nothing in this section shall be construed to

114 create a business-to-business exemption of any kind regardless of whether a current business relationship

115 exists between the holder and the owner.

116 2. “Non-escheat capital credits,” as defined in § 909 of Title 26.

117 3. Layaway accounts issued or maintained by any person in the business of selling tangible personal

118 property at retail.

119 4. A loyalty card.

120 (20) “Record” means information that is inscribed on a tangible medium or that is stored in an electronic or

121 other medium and is retrievable in perceivable form.

122 (21) “Security” means any of the following:

123 a. A share, participation, debt obligation or similar interest issued by a corporation, business trust, joint

124 stock company, or similar entity.

125 b. A share or similar equity interest issued by an entity that is registered as an investment company under

126 the federal investment company laws.

127 c. An interest in a unit investment trust that is so registered.

128 d. A face-amount certificate issued by a face-amount certificate company that is so registered.

129 e. An interest in a partnership or limited liability company that is dealt in or traded on securities

130 exchanges or in securities markets.

131 f. All financial assets maintained in an account, but not the physical securities held in a safe deposit box

132 or other safekeeping repository.

133 (22) “Sign” means to do one of the following with present intent to authenticate or adopt a record:

134 a. Execute or adopt a tangible symbol.

135 b. Attach to or logically associate with the record an electronic symbol, sound, or process.

136 (23) “State” means a state of the United States, the District of Columbia, the Commonwealth of Puerto Rico,

137 the United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the United States.

138 (24) “State Escheator” means the person responsible for the administration and enforcement of this chapter, as

139 established by § 1102 of this title and § 363 of Title 30.

140 (25) “Stored-value card” means a record that evidences a promise for consideration by the holder of the record

141 that the owner of the record will be provided, solely or a combination of, merchandise, services, or cash in the value

142 shown in the record, which is pre-funded and the value of which may be increased by the owner or holder or decreased
143 by redemption.

144 (26) “Uninvoiced payables” means amounts due “between merchants,” as defined in § 2-104 of Title 6, from a
145 holder who is a buyer to a creditor who is the seller of goods ordered by a holder in the ordinary course of business
146 when the goods were received and accepted by the holder, but which for any reason were never invoiced by the seller.
147 Uninvoiced payables include the value of goods received by a holder from a seller from out of balance transactions
148 where the holder's purchase order for goods and the amount of goods received by the holder do not match.
149 “Uninvoiced payables” include unsolicited goods received by a holder from a seller that fall within § 2505 of Title 6.
150 “Uninvoiced payables” do not include accounts payable, accounts receivable, or any other type of credit or amount due
151 to the creditor, including uncashed checks of any kind whatsoever whether relating to inventory, goods, or services,
152 and all of these types of property are still reportable as unclaimed property.

153 (27) “Utility” means a person that owns or operates for public use a plant, equipment, real property, franchise,
154 or license for any the following public services:

- 155 a. Transmission of communications or information.
156 b. Production, storage, transmission, sale, delivery, or furnishing of electricity, water, steam, or gas.
157 c. Provision of sewage and septic services, or trash, garbage, or recycling disposal.

158 (28) “Virtual currency” means a digital representation of value used as a medium of exchange, unit of
159 account, or store of value, which does not have legal tender status recognized by the United States. The term does not
160 include a loyalty card.

161 (29) “Worthless security” means a security whose cost of liquidation and delivery would exceed the value of
162 the security on the date a report is due under this chapter.

163 § 1131. Inapplicability to wholly foreign transaction.

164 This chapter does not apply to property held, due, and owing in a foreign country if the transaction involving the
165 property was a wholly foreign transaction.

166 § 1132. Rule making.

167 Except as provided in §§ 1171, 1177(a), and 1180(a) of this title, the State Escheator may make such rules and
168 regulations as the State Escheator may deem necessary to administer and enforce this chapter.

169 § 1133. When property presumed abandoned.

170 Subject to § 1136 of this title, property is presumed abandoned if it is unclaimed by the owner at the time specified
171 for the following property:

172 (1) A traveler’s check, 15 years after issuance.

173 (2) A money order, 5 years after issuance.

174 (3) A bearer bond or an original-issue-discount bond, 5 years after the earliest of the date the bond matures or
175 is called or the obligation to pay the principal of the bond arises.

176 (4) Interest on debt of a business association, 5 years after the obligation to pay arises.

177 (5) A demand, savings, or time deposit, including a deposit that is automatically renewable, 5 years after the
178 earlier of maturity or the date of the last indication of interest in the property by the owner, except a deposit that is
179 automatically renewable is deemed matured on its initial date of maturity unless the owner consented in a record on file
180 with the holder to a renewal at or about the time of the renewal.

181 (6) Money or credits owed to a customer as a result of a retail business transaction, 5 years after the obligation
182 arose.

183 (7)a. An amount owed by an insurance company on a life or endowment insurance policy or an annuity
184 contract that has matured or terminated, upon one of the following:

185 1. Five years after knowledge of death of the insured.

186 2. One year after the date the insured has attained, or would have attained if living, the limiting age
187 under the mortality table on which the reserve is based in the case of a policy or annuity payable upon death
188 where the obligation to pay did not arise under paragraph (7)a.1. of this section.

189 b. For purposes of this paragraph (7) of this section:

190 1. “Knowledge of death” means either of the following:

191 A. Receipt of an original or valid copy of a certified death certificate.

192 B. A death master file match validated by the insurer based on a good faith effort within 90 days
193 of notice of the death master file match.

194 2. “Death master file” means the United States Social Security Administration’s Death Master File or
195 other database or service that is at least as comprehensive as that file for determining that a person has died.

196 (8) Property distributable by a business association in the course of dissolution, 5 years after the property
197 becomes distributable.

198 (9) Property held by a court, including property received as proceeds of a class action, 5 years after the
199 property becomes distributable.

200 (10) Property held by a government or governmental subdivision, agency, or instrumentality, including state
201 and municipal bond interest and unredeemed principal under the administration of a paying agent or indenture trustee,

202 5 years after the property becomes distributable.

203 (11) Wages, including commissions, bonuses, or reimbursements to which an employee is entitled, or other
204 compensation for personal services, 5 years after the amount becomes payable.

205 (12) A deposit or refund owed to a subscriber by a utility, 5 years after the deposit or refund becomes payable.

206 (13) A security 3 years after the last indication of interest in the property.

207 (14) A stored-value card or gift card, 5 years after the later of the date of purchase, the addition of funds to the
208 stored-value card or gift card, a verification of the balance by the owner, or the last indication of interest in the
209 property. For a stored-value card or gift card, the amount unclaimed is the net card value minus an amount representing
210 the maximum cost to the issuer of the merchandise, goods, or services represented by the card.

211 (15) Property in an individual retirement account that is qualified for tax deferral under the income tax laws of
212 the United States, upon one of the following:

213 a. Three years after the date of the required distribution, specified in the income tax laws of the United
214 States by which distribution of the property must begin in order to avoid a tax penalty.

215 b. Three years after knowledge of death of the owner, either before or after reaching the age of required
216 distribution and the beneficiary has not contacted the business association within three years after the date of
217 death;

218 (16) Sums held for the payment of outstanding pari-mutuel tickets from the meet, 1 year following the last day
219 of the meet.

220 (17) All other property not specified in this section or § 1134 of this title, the earlier of 5 years after the owner
221 first has a right to demand the property or the obligation to pay or distribute the property arises.

222 § 1134. When contents of safe deposit box presumed abandoned.

223 Proceeds from a sale of tangible property held in a safe deposit box by the holder permitted by law of this State
224 other than this chapter are presumed abandoned if the property remains unclaimed by the owner 5 years after the earlier of
225 one of the following:

226 (1) The expiration of the lease or rental period for the box.

227 (2) The earliest date when the lessor of the box is authorized by law of this State other than this chapter to
228 enter the box and remove or dispose of the contents without consent or authorization of the lessee.

229 § 1135. When related property interest presumed abandoned.

230 At the time an interest is presumed abandoned under this chapter, any other property right accrued or accruing to
231 the owner as a result of the interest, and not previously presumed abandoned, is also presumed abandoned.

232 § 1136. Indication of owner interest in property.

233 (a) Property is not presumed abandoned if the owner indicates an interest in the property during the applicable
234 periods in this chapter.

235 (b) An indication of an owner's interest in property includes any of the following:

236 (1) A record communicated by the owner to the holder or agent of the holder concerning the property or the
237 account in which the property is held.

238 (2) An oral communication by the owner to the holder or agent of the holder concerning the property or the
239 account in which the property is held, if the holder or its agent contemporaneously makes and preserves a record of the
240 fact of the owner's communication.

241 (3) Presentment of a check or other instrument of payment of a dividend, interest payment, or other
242 distribution.

243 (4) Activity directed by an owner in the account in which the property is held, including accessing the account
244 or information concerning the account, or a direction by the owner to increase, decrease, or otherwise change the
245 amount or type of property held in the account.

246 (5) Subject to subsection (d) of this section, payment of a premium on an insurance policy.

247 (c) A communication with an owner by a person other than the holder or the holder's representative is not an
248 indication of the owner's interest in the property unless a record of the communication evidences the owner's knowledge of
249 a right to the property.

250 (d) Application of an automatic-premium-loan provision or other nonforfeiture provision contained in an insurance
251 policy is not an indication of the insured's interest in the policy and does not prevent the policy from maturing or
252 terminating if the insured has died or the insured or the beneficiary of the policy otherwise has become entitled to the
253 proceeds before depletion of the cash surrender value of the policy by application of the provision.

254 (e) If the property is either held within accounts established for automatic electronic deposit of dividends ("ACH
255 Accounts") or within accounts established as part of a dividend reinvestment plan, including mutual fund accounts and
256 brokerage accounts (collectively, "DRP Accounts"), the mailing of an IRS Form 1099 relating to the investment or account
257 by the holder or its agent to the owner that is not returned to the holder or its agent by the United States Postal Service is an
258 indication of the owner's interest in the property.

259 (f) For purposes of a security where the last-known address of the owner is in a foreign country, an executed Form
260 W-8 BEN from the owner dated within 3 years of the end of any calendar year on file with the holder or its agent is an
261 indication of the owner's interest in the property.

262 (g) If an owner has more than one investment or account with a holder, an indication of owner interest with respect
263 to one investment or account with that holder is an indication of the owner's interest in all accounts of the owner with
264 respect to that holder.

265 § 1137. Knowledge of death.

266 Knowledge of death regarding an owner's interest in property may be identified through any source, including a
267 declaration of death, death certificate, a comparison of the holder's records against the Social Security Death Master File, or
268 other equivalent resources.

269 § 1138. Retained asset account for insurance policy or annuity contract.

270 If proceeds payable under a life or endowment insurance policy or annuity contract are deposited into an account
271 with check or draft writing privileges for the beneficiary of the policy or contract and the proceeds are retained by the
272 insurance company or its agent under a supplementary contract not involving annuity benefits other than death benefits, the
273 policy or contract includes the assets in the account.

274 § 1139. Address of owner to establish priority

275 (a) The last-known address of an owner is a description, code, or other indication of the location of the owner on
276 the holder's books and records which identifies the state of the last-known address of the owner.

277 (b) The address of the owner of a life or endowment insurance policy or annuity contract or its proceeds is
278 presumed to be the address of the insured or annuitant if a person other than the insured or annuitant is entitled to the
279 amount owed under the policy or contract and the address of the other person is not known by the insurance company and
280 cannot be determined under § 1140 of this title.

281 § 1140. Address of owner in this State.

282 The State Escheator may take custody of property that is presumed abandoned, whether located in this State or
283 another state, or in a foreign country if the last-known address of the owner, as shown on the records of the holder, is in this
284 State.

285 § 1141. Holder domiciled in this State.

286 (a) Except as otherwise provided in subsection (b) of this section or § 1140 of this title, the State Escheator may
287 take custody of property presumed abandoned, whether located in this State, another state, or a foreign country, if the
288 holder is domiciled in this State or is the State or a governmental subdivision, agency, or instrumentality of this State, and
289 any of the following circumstances are met:

290 (1) Another state is not entitled to the property because there is no last-known address in the records of the
291 holder of the owner or other person entitled to the property.

292 (2) The state of the last-known address of the owner or other person entitled to the property does not provide
293 for custodial taking of the property.

294 (3) The last-known address of the owner is in a foreign country.

295 (b) Property is not subject to custody of the State Escheator under subsection (a) of this section if the property is
296 specifically exempt from custodial taking under the law of this State or the state of the last-known address of the owner.

297 (c) If the holder's state of domicile has changed since the time the property was presumed abandoned, the holder's
298 state of domicile in this section is deemed to be the state where the holder was domiciled at the time the property was
299 presumed abandoned.

300 § 1142. Report required by holder.

301 (a) A holder of property presumed abandoned and subject to the custody of the State Escheator shall file an annual
302 report to the State Escheator concerning the property. Beginning March 1, 2018, all reports under this section must be in a
303 web-based record, and the State Escheator may not accept any other medium or method for submitting the report.

304 (b) A holder may contract with a third party to make the report required under subsection (a) of this section.

305 (c) If a holder contracts with a third party under subsection (b) of this section, the holder is responsible to the State
306 Escheator for all of the following:

307 (1) The complete, accurate, and timely reporting of property presumed abandoned.

308 (2) Paying or delivering to the State Escheator property described in the report filed under this section.

309 § 1143. Content of report.

310 (a) The report required under § 1142 of this title must do all of the following:

311 (1) Be signed by or on behalf of the holder and verified as to its completeness and accuracy.

312 (2) Describe the property.

313 (3) Except for a traveler's check or money order, contain the following information about the owner of the
314 property: the name, if known; the last-known address, if known; and the Social Security number or taxpayer
315 identification number, if known or readily ascertainable.

316 (4) For an amount held or owing under a life or endowment insurance policy or annuity contract, contain the
317 full name and last-known address of the insured, annuitant, or other owner of the policy or contract and of the
318 beneficiary.

319 (5) Contain the commencement date for determining abandonment under § 1133 of this title.

320 (6) State that the holder has complied with the notice requirements of § 1148 of this title.

321 (7) Identify property that is a non-freely transferable security, and explain why it is a non-freely transferable

322 security.

323 (8) Identify a designated individual employed by the holder who will serve as the contact for all
324 correspondence with the State related to the reporting and remittance of unclaimed property under this chapter and
325 contain the designated individual's mailing address, telephone number, email address, and title. The holder must notify
326 the State of any change of the designated individual or any information provided about the designated individual.

327 (9) Contain other information which the State Escheator may prescribe.

328 (b) A report under § 1142 of this title may include personal information about the owner or the owner's property to
329 the extent such information is not otherwise prohibited by federal law. Any personal information, and disclosure of such
330 information, must be treated in accordance with § 1193 of this title.

331 (c) If a holder has changed the holder's name while holding property presumed abandoned or is a successor to
332 another holder that previously held the property for the owner, the holder shall include in the report under § 1142 of this
333 title the holder's former name or the name of the previous holder, if any, and the known name and address of each previous
334 holder of the property.

335 (d) No reporting shall be required solely by virtue of holding property constituting consideration paid for
336 unredeemed gift cards which, in the aggregate, for the reporting period have a face value of less than \$5,000 or for gift
337 cards having a face value of \$5.00 or under issued by a holder whose business is described in § 2906 of Title 30, whether or
338 not such firm conducts business in this State.

339 § 1144. When report to be filed.

340 (a) Subject to subsection (d) of this section, the report under § 1142 of this title pertaining to property designated
341 under § 1133 of this title must be filed by all holders and business associations other than banking organizations and
342 insurance companies on or before March 1 of each year to cover the 12 months preceding January 1 of that year.

343 (b) Subject to subsection (d) of this section, the report under § 1142 of this section pertaining to property
344 designated under § 1133 of this title must be filed by banking organizations on or before November 10 of each year to cover
345 the 12 months preceding July 1 of that year.

346 (c) Subject to subsection (d) of this section, the report under § 1142 of this title pertaining to property designated
347 under § 1133 of this title must be filed by insurance companies on or before December 20 of each year to cover the 12
348 months preceding January 1 of that year.

349 (d) Before the date for filing the report under § 1142 of this title, the holder of property presumed abandoned may
350 request an extension of the date of filing from the State Escheator. The State Escheator may grant an extension for good
351 cause. If the State Escheator grants an extension, the holder may pay or make a partial payment of the amount the holder

352 estimates ultimately will be due. The payment or partial payment terminates accrual of interest on the amount paid.

353 § 1145. Retention of records by holder.

354 A holder required to file a report under § 1142 of this title shall retain records for 10 years after the date the report
355 was filed, unless a shorter period is provided by the State Escheator by rule or regulation. A holder may satisfy the
356 requirement to retain records under this section through an agent. The records retained must contain all of the following:

357 (1) The verifiable information required to be included in the report.

358 (2) The date, place, and nature of the circumstances that gave rise to the property right.

359 (3) The amount or value of the property.

360 (4) The last address of the owner, if known to the holder.

361 (5) If the holder sells, issues, or provides to others for sale or issue in this State traveler's checks or money
362 orders, a record of the instruments while they remain outstanding indicating the state and date of issue.

363 § 1146. When property reportable and payable or deliverable.

364 Property is reportable and payable or deliverable under this chapter even if the owner fails to make demand or
365 present an instrument or document otherwise required to obtain payment.

366 § 1147. Limitation on assignment or transfer of liability

367 (a) A holder may not assign or otherwise transfer its obligation to hold for or pay or deliver property or to comply
368 with the duties of this chapter, other than to a parent, subsidiary, or affiliate of the holder.

369 (b) Unless otherwise agreed to by the parties to a transaction, the holder's successor by merger or consolidation, or
370 any person or entity that acquires all or substantially all of the holder's capital stock or assets shall be responsible for
371 fulfilling the holder's obligation to hold for or pay or deliver property or to comply with the duties of this chapter regarding
372 the transfer to it of property owed to and being held for an owner resulting from the merger, consolidation, or acquisition.

373 (c) Nothing in this section prohibits a holder from contracting with a third party for the reporting of unclaimed
374 property. But, a holder shall remain responsible to the State Escheator for the complete, accurate, and timely reporting of
375 the property.

376 § 1148. Notice to owner by holder.

377 The holder of property presumed abandoned shall send to the owner notice that complies with § 1149 of this title
378 to the owner in a format acceptable to the State Escheator, by first-class United States mail, not more than 120 days nor less
379 than 60 days before filing the report under § 1142 of this title if both of the following apply:

380 (1) The holder has in its records an address for the owner sufficient to direct the delivery of first-class United
381 States mail to the owner, which the holder's records do not disclose to be invalid.

382 (2) The value of the property is \$50 or more, unless the property is a security, in which case the holder must
383 send notice to the owner regardless of the value of the property.

384 § 1149. Contents of notice by holder.

385 (a) The notice under § 1148 of this title must contain a heading that reads as follows: “Notice. The State of
386 Delaware requires us to notify you that your property will be transferred to the custody of the State Escheator if you do not
387 contact us before [insert date that is 30 days after the date of this notice.]”

388 (b) The notice under § 1148 of this title must do all of the following:

389 (1) State that the property will be turned over to the State Escheator.

390 (2) State that after the property is turned over to the State Escheator an owner that seeks return of the property
391 may file a claim.

392 (3) Identify the nature and, except for property that does not have a fixed value, the value of the property that
393 is the subject of the notice.

394 (4) State that property that is not legal tender of the United States may be sold by the State Escheator.

395 (5) Provide instructions that the owner must follow to prevent the holder from reporting and paying or
396 delivering the property to the State Escheator.

397 § 1150. Notice to owner by State Escheator.

398 (a) Subject to subsection (b) of this section, the State Escheator shall send written notice to an owner prior to
399 liquidation that a security or other property that is not money presumed abandoned and appears to be owned by the owner is
400 held by the State Escheator under this chapter.

401 (b) In providing notice under subsection (a) of this section, the State Escheator shall send written notice to each
402 owner of a security or other property that is not money held by the State Escheator to the last-known address of the owner
403 contained in the records of the holder as provided to the State Escheator, unless the State Escheator determines that the
404 notice would not be received by the owner or the State Escheator determines that the total value of the security or other
405 property that is not money does not exceed \$50.

406 (c) The State Escheator and the State of Delaware shall not be liable to an owner based upon the liquidation of a
407 security or other property that is not money if notice has been sent as provided by this section and if the State Escheator has
408 not acted unreasonably in determining that mailed notice would not be received by the owner. Except with respect to the
409 provisions of § 1162(a)(2) of this title, the State Escheator and the State of Delaware are not liable to the owner of a
410 security or other property that is not money for an amount that exceeds that which was actually received upon the
411 liquidation of the security.

412 (d) In June and December of each year, the State Escheator shall publish in a daily newspaper of this State a notice
413 that unclaimed property paid to the State Escheator is available to be claimed by the owners of the unclaimed property.

414 (e) The notice required by subsection (d) of this section shall be in such form and classified in such manner as the
415 State Escheator shall determine, except that the notice shall do all of the following:

416 (1) Occupy at least one-half page in a daily newspaper of this State.

417 (2) Provide the Uniform Resource Locator address of an internet-based searchable database that includes the
418 names of all persons appearing to be entitled to any unclaimed property.

419 (3) Provide a toll-free customer service telephone number.

420 (4) Contain a statement that a claim for any unclaimed property must be filed with the State Escheator.

421 (f) Subject to the limitations of § 1193 of this title, the internet-based searchable database required by paragraph
422 (e)(2) of this section must set forth all of the following:

423 (1) The names and last-known addresses of all persons appearing from the records in the State Escheator's
424 office to be entitled to receive unclaimed property that consists of money in an amount not less than \$10.

425 (2) The names and last-known addresses of all persons appearing from the records in the State Escheator's
426 office to be entitled to receive unclaimed property that consists of personal property other than money and that the
427 State Escheator has not determined under § 1156(a)(1) of this title to be valueless or of such little value that a sale of
428 the property would cost in excess of the probable proceeds from the property.

429 (3) If any unclaimed property consisted of personal property other than money and was converted into money
430 under § 1159 of this title and such money amounted to \$10 or more, the names and last-known addresses of the persons
431 appearing from the records in the State Escheator's office to be entitled to receive the money.

432 (4) Other information as the State Escheator may prescribe.

433 (g) The State Escheator shall regularly update the internet-based searchable database, and shall include in the
434 database, at a minimum, all data received by the State 6 months immediately preceding the publication dates specified in
435 subsection (d) of this section.

436 (h) The State Escheator may not include in the internet-based searchable database the names and last-known
437 addresses of persons whose claims for unclaimed property have been satisfied previously.

438 (i) Notwithstanding the foregoing provisions of this section, the State Escheator may omit from such internet-
439 based searchable database the name and last-known address of any person if special circumstances make it desirable that
440 such information be withheld.

441 (j) The State Escheator and the State of Delaware are not liable to an owner, absent gross negligence or intentional

442 misconduct, for the failure to publish a notice of unclaimed property under subsection (d) of this section or the failure to
443 include the name, address, and other information regarding a person entitled to receive property under subsection (f) of this
444 section.

445 § 1151. Cooperation among agencies to determine owner.

446 Unless prohibited by law of this State other than this chapter, on request of the State Escheator, each officer,
447 agency, board, commission, division, and department of this State; any body politic and corporate created by this State for a
448 public purpose; and each political subdivision of this State may make its books and records available to the State Escheator
449 and cooperate with the State Escheator to determine the current address of an owner of property held by the State Escheator
450 under this chapter.

451 § 1152. RESERVED.

452 § 1153. Payment or delivery of property to State Escheator.

453 (a) Except as otherwise provided in this section, on filing a report under § 1142 of this title, the holder shall pay or
454 deliver to the State Escheator the property described in the report.

455 (b) If property in a report under § 1142 of this title is an automatically renewable deposit and a penalty or
456 forfeiture in the payment of interest would result from paying the deposit to the State Escheator at the time of the report, the
457 date for payment of the property to the State Escheator is extended until a penalty or forfeiture no longer would result from
458 payment, if the holder informs the State Escheator of the extended date.

459 (c) If property reported to the State Escheator under § 1142 of this title is a security, the State Escheator may do
460 either of the following:

461 (1) Make an endorsement, instruction, or entitlement order on behalf of the owner to invoke the duty of the
462 issuer, its transfer agent, or the securities intermediary to transfer the security.

463 (2) Dispose of the security under § 1161 of this title.

464 (d) The State Escheator shall establish procedures for the registration, issuance, method of delivery, transfer, and
465 maintenance of securities delivered to the State Escheator by a holder.

466 (e) A holder is not required to deliver to the State Escheator a security identified by the holder as a non-freely
467 transferable security. Upon determination by the State Escheator or the holder that a security is no longer a non-freely
468 transferable security, the holder shall remit the security on the next regular date prescribed for delivery of securities under
469 this chapter. The holder shall annually determine whether a security identified in a report filed under § 1142 of this title as a
470 non-freely transferable security is no longer a non-freely transferable security.

471 § 1154. Effect of payment or delivery of property to State Escheator.

472 (a) Unless otherwise addressed in subsection (b) of this section, the holder's payment or delivery of property to the
473 State Escheator terminates any legal relationship between the holder and the owner with respect to the property reported
474 and releases and discharges the holder from any and all liability to the owner, the owner's heirs, personal representatives,
475 successors, or assigns by reason of such payment or delivery, regardless of whether such property is in fact and in law
476 abandoned property and such delivery and payment may be pleaded as a bar to recovery and shall be a conclusive defense
477 in any suit or action brought by such owner, the owner's heirs, personal representatives, successors and assigns or any
478 claimant against the holder by reason of such delivery or payment. Application of this subsection (a) is mutually exclusive
479 of subsection (b) of this section and, accordingly, may not be applied in conjunction with subsection (b) of this section.

480 (b) Upon the delivery in good faith of a duplicate certificated security to the State Escheator or the registration of
481 an uncertificated security to the State Escheator under § 1153 of this title, the holder and any transfer agent, registrar, or
482 other person acting for or on behalf of the holder in executing or delivering such duplicate certificate or effectuating such
483 registration, is relieved of all liability of every kind to every person, including any person acquiring the original of a
484 certificated security or the duplicate of a certificated security issued to the State Escheator for any losses or damages
485 resulting to any person by issuance and delivery to the State Escheator of the duplicate certificated security or the
486 registration to the holder's name of an uncertificated security.

487 (c) If a holder pays or delivers property to the State Escheator in good faith and thereafter another person claims
488 the property from the holder or another state claims the money or property under its laws relating to escheat or abandoned
489 or unclaimed property, the State Escheator, acting on behalf of the State, upon written notice of the claim, shall defend the
490 holder against the claim and indemnify the holder against any liability on the claim.

491 (d) For the purposes of this section, "good faith" means that all of the following apply:

492 (1) Payment or delivery was made in a reasonable attempt to comply with this chapter.

493 (2) The person delivering the property was not a fiduciary then in breach of trust in respect to the property
494 and had a reasonable basis for believing, based on the facts then known to the person, that the property was abandoned
495 for the purposes of this chapter.

496 (3) There is no showing that the records pursuant to which the delivery was made did not meet reasonable
497 commercial standards of practice in the industry.

498 (e) Under § 1156(b) of this title, at the request of a holder, the State Escheator may allow the holder to pay over or
499 deliver property otherwise properly payable to the State but against which a full period of dormancy has not yet run. If the
500 State Escheator grants the holder's request and accepts the property, the holder is entitled to the protections of this section
501 and the property is to be treated generally as if it had been paid over or delivered after a full period of dormancy had run.

502 Section 1155 of this title does not apply to property accepted by the State Escheator under this subsection until a full period
503 of dormancy has run against the property.

504 § 1155. Interest not to run after report of property and limitation on claims.

505 (a) Notwithstanding any other provision of law, no person entitled to or owner of property shall be entitled to
506 receive interest on account of such property from and after the date a report of such property is made to the State Escheator
507 under this chapter whether or not the person was entitled to interest on such property prior to such date.

508 (b) No person has any claim under this chapter against the State, the holder, any transfer agent, registrar, or other
509 person acting for or on behalf of a holder for or on account of any appreciation or depreciation in the value of the property
510 occurring after delivery by the holder to the State Escheator in good faith, as defined in § 1154(d) of this title, except with
511 respect to the State Escheator as provided by and in the circumstances specified in § 1162(a)(2) of this title.

512 § 1156. State Escheator's options as to custody.

513 (a) The State Escheator may decline to take custody of property reported under § 1142 of this title if the State
514 Escheator determines one of the following:

515 (1) The property has a value less than the estimated expenses of notice and sale of the property.

516 (2) Taking custody of the property would be unlawful.

517 (b) A holder may pay or deliver property to the State Escheator before the property is presumed abandoned under
518 this chapter if the holder does all of the following:

519 (1) Sends the owner of the property the notice required by § 1148 of this title and conforming to § 1149 of this
520 title.

521 (2) Provides to the State Escheator evidence of the holder's compliance with paragraph (b)(1) of this section.

522 (3) Includes with the payment or delivery a report regarding the property conforming to § 1142 of this title.

523 (4) First obtains the State Escheator's consent in a record to accept payment or delivery.

524 (c) A holder's request for the State Escheator's consent under subsection (b)(3) of this section must be in a record.
525 If the State Escheator fails to respond to the request not later than 90 days after receipt of the request, the State Escheator is
526 deemed to consent to the payment or delivery of the property and the payment or delivery is considered to have been made
527 in good faith, as defined in § 1154(d) of this title.

528 (d) On payment or delivery of property under subsection (b) of this section, the property is presumed abandoned.

529 § 1157. Periods of limitation.

530 (a) Expiration, before, on, or after [the effective date of this Act], of a period of limitation on an owner's right to
531 receive or recover property, whether specified by contract, statute, or court order, does not prevent the property from being

532 presumed abandoned or affect the duty of a holder to file a report or pay or deliver property to the State Escheator under
533 this chapter.

534 (b) The State Escheator may not commence an action or proceeding to enforce this chapter with respect to the
535 reporting, payment, or delivery of property more than 10 years after the duty arose. The period of limitation established by
536 this subsection is tolled by the State Escheator's delivery of a notice of an examination to a holder under this chapter, or if
537 the State Escheator reasonably concludes that the holder has filed a report containing a fraudulent or wilful
538 misrepresentation.

539 § 1158. No private escheat.

540 Any provision in a certificate of incorporation, bylaw, trust agreement, contract, or any other writing regulating the
541 relationships between an owner and a holder, which relates to property that is or may be subject to the provisions of this
542 chapter, with the exception of "non-escheat capital credits" as defined in § 909 of Title 26, and which provides that upon
543 the owner's failure to act or make a claim regarding property in possession of the holder that the property reverts to or
544 becomes the property of the holder is void and unenforceable.

545 § 1159. Public sale of property.

546 (a) All property, other than money, delivered to the State Escheator under this chapter may be sold or disposed of
547 at public auction to the highest bidder or in such manner and at such times as the State Escheator determines to be in the
548 best interest of the State. The State Escheator may dispose of securities by sale through a registered broker on a recognized
549 securities exchange or over the counter market or, if there is no ready market for such security, by negotiation or public
550 auction.

551 (b) The State Escheator shall hold the proceeds from a sale of property, other than money, delivered to the State
552 Escheator, less all costs incurred in connection with the sale, in the place of the property and any claimant of the property is
553 entitled only to the money so received, less lawful service charges.

554 (c) The State Escheator is not liable in any action for any act made in good faith under this section.

555 § 1160. Sale of property.

556 All property, other than money, delivered to the State Escheator under this chapter shall be sold or disposed of in
557 accordance with § 1159 of this title.

558 § 1161. Disposal of securities.

559 If a security is delivered to the State Escheator under this chapter on or after July 1, 2017, the State Escheator
560 shall, subsequent to satisfying the notice requirements of § 1150 of this title, sell the security on any established stock
561 exchange or by such other means as the State Escheator deems advisable as soon as the State Escheator deems practicable

562 after the delivery. The State Escheator may not sell a security listed on an established stock exchange for less than the price
563 prevailing on the exchange at the time of sale. The State Escheator may sell a security not listed on an established
564 exchange by any commercially-reasonable method.

565 § 1162. Recovery of securities or value by owner.

566 (a) Beginning on July 1, 2017, a person that makes a valid claim under this chapter of ownership of a security
567 following delivery of a security to the State Escheator is entitled to receive from the State Escheator one of the following:

568 (1) If the security is in the custody of the State Escheator at the time of the claim, the security the holder
569 delivered to the State Escheator, plus dividends, interest, and other increments on the security up to the time the claim
570 is paid, to the extent paid to the State Escheator.

571 (2) If the claim is made within 18 months from the date notice was mailed by the State Escheator to the
572 rightful owner under § 1150 of this title, the replacement of the security or the market value of the security at the time
573 the claim is filed, at the option of the State Escheator.

574 (3) If the claim is made more than 18 months after the date notice was mailed by the State Escheator to the
575 rightful owner under § 1150 of this title, the net proceeds of the sale of the security, plus dividends, interest, and other
576 increments on the security up to the time the security is sold, to the extent paid to the State Escheator.

577 (b) The State Escheator is not liable in any action for any act of his made in good faith under this section.

578 § 1163. Purchaser owns property after sale.

579 All sales of property made by the State Escheator under this chapter pass absolute title to the purchaser. The State
580 Escheator or the Secretary of State shall execute all documents necessary to complete the transfer of title.

581 § 1164. Military medals.

582 (a) A financial institution may not sell a medal or decoration awarded for military service in the armed forces of
583 the United States.

584 (b) A financial institution, with the consent of the respective organization under paragraph (b)(1) of this section,
585 agency under paragraph (b)(2) of this section, or entity under paragraph (b)(3) of this section, may deliver a medal or
586 decoration described in subsection (a) of this section to be held in custody for the owner, to one of the following:

587 (1) A military veterans organization qualified under 26 U.S.C. §501(c)(19).

588 (2) The agency that awarded the medal or decoration.

589 (3) A governmental entity.

590 § 1165. Deposit of funds by State Escheator.

591 (a) Subject to limitations contained in § 6102(s) of Title 29, the State Escheator shall deposit into the General Fund

592 all moneys or proceeds of property received pursuant to this chapter.

593 (b) The payment of all claims, the right to which is established under this chapter, shall be made from the General
594 Fund upon voucher signed by the State Escheator.

595 § 1166. Deposit and disbursement of funds.

596 (a) The State Escheator shall immediately deposit all funds received by the State Escheator under this chapter,
597 including the proceeds of sale under § 1160 of this title, into the General Fund.

598 (b) The Secretary of Finance shall pay all disbursements, including disbursements for expenses, claims, or storage,
599 made or authorized by the State Escheator in connection with the administration of this chapter upon presentation of a
600 signed voucher by the State Escheator.

601 § 1167. State Escheator to retain records of property.

602 The State Escheator shall record and retain the holder report filed under § 1142 of this title and the information
603 contained in the report for at least 10 years after the report was filed.

604 § 1168. RESERVED.

605 § 1169. Claim for property by person claiming to be owner.

606 (a) Any person claiming an interest in any property paid or delivered to the State Escheator under this chapter may
607 file a claim with the State Escheator for the property or for the proceeds from the sale of the property.

608 (b) The determination of claims and rights of appeal are as prescribed in § 1171 of this title.

609 § 1170. When State Escheator must honor claim for property.

610 (a) The State Escheator shall pay or deliver property to a claimant under § 1169 of this title if the State Escheator
611 receives evidence sufficient to establish to the reasonable satisfaction of the State Escheator that the claimant is the owner
612 of the property.

613 (b) The State Escheator shall allow or deny the claim and give the claimant notice of the decision in a record. If
614 the claim is denied the State Escheator shall do all of the following:

615 (1) Inform the claimant of the reason for the denial and specify what additional evidence, if any, is required
616 for the claim to be allowed.

617 (2) Treat an amended claim as an initial claim under this section.

618 § 1171. Claims and rights of appeal.

619 (a) The State Escheator shall possess full and complete authority to determine all claims filed under § 1169 of this
620 title and shall immediately send written notice of such determination to the claimant. At any time within 4 months after the
621 State Escheator sends notice of a determination, a claimant may apply for a hearing and determination of the claim by the

622 Tax Appeal Board created by Subchapter II, Chapter 3, Title 30. The procedure before the Tax Appeal Board for such
623 hearings is the same as that provided for by § 329 of Title 30 and the Board has the same power to compel the attendance of
624 witnesses and the production of evidence as is provided in § 330 of Title 30.

625 (b) Within 30 days after notice of the Tax Appeal Board's decision, the State Escheator or a claimant may appeal
626 the decision to the Court of Chancery upon notice to all parties to the proceeding before the Tax Appeal Board and upon
627 such other notice as the Court of Chancery may order.

628 (c) The Court of Chancery may make such rules as it deems proper for the perfection, hearing and determination
629 of such appeals.

630 § 1172. Payment by State Escheator.

631 Any claim which is allowed by, or ordered to be paid by, the State Escheator pursuant to § 1169 of this title,
632 together with such costs and disbursements as may be allowed by the Court of Chancery or the Tax Appeal Board, must be
633 paid out of the General Fund. The State Escheator is not liable in any action for any claim paid in good faith.

634 § 1173. Allowance of claim for property.

635 (a) On request of the owner, the State Escheator may sell or liquidate a security and pay the net proceeds to the
636 owner.

637 (b) At the discretion of the State Escheator, property of an owner is subject to a claim for payment of an
638 enforceable debt that the owner owes in this State for any of the following:

639 (1) Child-support arrearages, including child-support collection costs and child- support arrearages that are
640 combined with maintenance.

641 (2) A civil or criminal fine or penalty, court costs, a surcharge, or restitution imposed by a final order of an
642 administrative agency or a final court judgment.

643 (3) State or local taxes, penalties, and interest that have been determined to be delinquent or as to which notice
644 has been recorded with the Secretary of the State or a local taxing authority.

645 (c) The State Escheator may make periodic inquiries of state and local agencies in the absence of a claim filed
646 under § 1169 of this title to determine whether owners included in the unclaimed property records of this state have
647 enforceable debts described in subsection (b) of this section.

648 (d) Before delivery or payment to an owner under subsection (a) of this section of property or net proceeds of a
649 sale of the property, the State Escheator may first apply the property or net proceeds to a debt under subsection (b) of this
650 section that the State Escheator has determined is owed by the owner. The State Escheator may pay the amount to the
651 appropriate state or local agency and notify the owner of the payment.

652 § 1174. Request for report of property; compliance reviews.

653 (a) If a person does not file a report required by § 1142 of this title or the State Escheator believes that a person
654 may have filed an inaccurate, incomplete, or false report, the State Escheator may require the person to file a verified report
655 in a form prescribed by the State Escheator. The verified report must do all of the following:

656 1. State whether the person is holding property reportable under this chapter.

657 2. Describe property not previously reported or about which the State has inquired or about which there is a
658 dispute as to whether it is reportable under this chapter.

659 3. State the amount or value of the property.

660 (b) If the State Escheator believes that a person may have filed an inaccurate, incomplete, or false report, including
661 a report submitted under §1174(a)(1) of this title, the State Escheator may authorize a compliance review of that report and
662 the notification requirements of §1176(a) of this title do not apply. The compliance review must be limited to the contents
663 of the report filed as required by §§ 1142, 1143, and 1174(a) of this title, and all supporting documents related to such
664 reports. If the compliance review results in a finding of a deficiency in unclaimed property due and payable to the State, the
665 State Escheator shall notify the holder in writing of the amount of deficiency within one year from the authorization of the
666 compliance review. If the holder fails to pay the deficiency within 90 days, the State Escheator may seek to enforce the
667 assessment pursuant to § 1184 of this title or may refer the holder to the Department of State in order to request that the
668 holder enter into an unclaimed property voluntary disclosure agreement under § 1177 of this title. The State Escheator shall
669 not be required to conduct a compliance review under this section prior to initiating an examination under §§1175 and 1176
670 of this title. The filing of a verified report or participation in a compliance review does not preclude the holder from
671 participating in the Secretary of State's voluntary disclosure program under § 1177 of this title.

672 § 1175. Examination to determine compliance with chapter.

673 The State Escheator, at reasonable times and on reasonable notice, may do any of the following:

674 (1) Examine the records of a person or the records in the possession of an agent, representative, subsidiary, or
675 affiliate of the person under examination in order to determine whether the person complied with this chapter.

676 (2) Take testimony of a person, including the person's employee, agent, representative, subsidiary, or affiliate,
677 to determine whether the person complied with this chapter.

678 (3) Issue an administrative subpoena to require that the records specified in paragraph (1) of this section be
679 made available for examination and that the testimony specified in paragraph (2) of this section be provided.

680 (4) Bring an action in the Court of Chancery seeking enforcement of an administrative subpoena issued under
681 paragraph (3) of this section, which the Court shall consider under procedures that will lead to an expeditious

682 resolution of the action.

683 § 1176. Rules and procedures for conducting an examination.

684 (a) Effective July 1, 2015 and subject to subsection (d) of this section, the State Escheator shall not initiate any
685 new examination of records or an investigation of any person under this section unless the person has first been notified in
686 writing by the Secretary of State that the person may enter into an unclaimed property voluntary disclosure agreement, or
687 the holder fails to otherwise comply with a requirement imposed on such holder pursuant to § 1177 of this title.

688 (b) Notwithstanding the provisions of § 1177(e)(3) of this title, for any examination authorized by the State
689 Escheator on or before July 22, 2015, except any securities examinations in which estimation is not required, the person
690 under such an examination may notify the State Escheator and the Secretary of State of the person's intent to convert the
691 pending examination into a review under the Secretary of State's voluntary disclosure program and to enter into the
692 Secretary of State's unclaimed property voluntary disclosure program under § 1177 of this title. The person shall, by July 1,
693 2017, notify the State Escheator and Secretary of State in writing in a form and manner provided by the State Escheator and
694 the Secretary of State. If such notice is not received by July 1, 2017, the person may not convert the examination into a
695 review under the Secretary of State's unclaimed property voluntary disclosure program under § 1177 of this title. The look
696 back period for any such voluntary disclosure permitted under this section is 10 years prior to when property is presumed
697 abandoned under this chapter from the calendar year in which the State Escheator provided the original notice of
698 examination.

699 (c)(1) For any examination authorized by the State Escheator before [the effective date of this Act], the person
700 under examination may notify the State Escheator of the person's intent to expedite the completion of the pending
701 examination by providing written notification on a form provided by the State Escheator that must be received by the State
702 Escheator by July 1, 2017.

703 (2) If the person provides the written notification under paragraph (c)(1) of this section and responds within
704 the time and in the manner established by the State Escheator to all requests for records, testimony, and information
705 made by the person conducting the examination, the State Escheator shall complete the examination and provide an
706 examination report under § 1181 of this title within 2 years from the date of receipt of the written notification and shall
707 waive interest and penalty under §§ 1187 and 1188 of this title.

708 (3) All requests for records, testimony, and information must be made by the person conducting the
709 examination to the person under examination no later than 18 months after the written notification under paragraph
710 (c)(1) of this section.

711 (4) The determination whether the person has responded within the time and in the manner established and a

712 resulting determination to terminate expediting the person's examination under this subsection if the person has not,
713 shall be within the complete discretion of the State Escheator and subject only to the review of the Secretary of
714 Finance.

715 (5) An examination report produced at the conclusion of the expedited examination shall be treated as any
716 other report after the conclusion of an examination of a holder under § 1183(a) of this title.

717 (d) The State Escheator may authorize an examination of records or an investigation of any person under this
718 section without the person having been notified in writing by the Secretary of State as outlined in subsection (a) of this
719 section in any of the following circumstances:

720 (1) Pursuant to information received under Chapter 12 of Title 6.

721 (2) As a joint examination initiated by another state under § 1186 of this title after consultation with the
722 Secretary of State.

723 (e) The State Escheator shall adopt rules governing procedures and standards for a compliance review under §
724 1174 of this title and an examination under § 1175 of this title, including rules for use of an estimation, extrapolation, and
725 statistical sampling in conducting an examination.

726 (f) If the person subject to examination under § 1175 of this title has filed all reports required by § 1142 of this title
727 and has retained the records required by § 1145 of this title, all of the following rules apply:

728 (1) The examination must include a review of the person's records.

729 (2) The examination may not be based upon an estimate unless the holder expressly consents in a record to
730 the use of an estimate.

731 (3) The person conducting the examination shall consider all evidence presented by the person in good faith in
732 preparing the findings of the examination under § 1181 of this title.

733 (g) Any examination under this section may include the State Escheator utilizing any and all reliable external data,
734 including electronic databases deemed relevant by the State Escheator.

735 (h) After [the effective date of this Act], the State Escheator may not conduct any examination of records or an
736 investigation under this section for any period more than 10 years prior to when property is presumed abandoned under this
737 chapter from the calendar year in which the State Escheator provides written notice of such examination, except if the State
738 Escheator reasonably concludes that the holder has filed a report containing a fraudulent or wilful misrepresentation.

739 § 1177. Voluntary property reporting outreach program.

740 (a) Notwithstanding any other provision of this title or Chapter 23 of Title 29, the Secretary of State may resolve
741 and compromise claims for property otherwise owing to the State Escheator under this chapter if a holder of such property

742 voluntarily discloses to the Secretary of State such property on or before the deadlines provided in this section.

743 (1) The Secretary of State shall waive interest and penalty under §§ 1187 and 1188 of this title for holders that
744 complete the voluntary disclosure in good faith.

745 (2) The Secretary of State shall possess full and complete authority to determine and resolve all such claims
746 consistent with this chapter and exercise such authorities as are granted to the State Escheator under this chapter.

747 (3) Notwithstanding paragraph (a)(2) of this section, any unclaimed property voluntary disclosure agreement
748 accepted by the Secretary of State is deemed as waiving the right of the Secretary of State and the State Escheator to
749 seek payment of any amounts of property under §§ 1157 or 1183 of this title as to the property voluntarily disclosed by
750 the holder in the agreement, except in circumstances where the Secretary of State reasonably concludes that there has
751 been a fraudulent or wilful misrepresentation as to any such voluntary disclosure by the holder or those acting on the
752 holder's behalf.

753 (4) If the Secretary of State is unable to resolve such claims by agreement, the Secretary of State may refer the
754 resolution of such claims to the State Escheator at any time.

755 (5) The care and custody of all property paid under this section is assumed for the benefit of those entitled to
756 receive the same and the Secretary of State shall have all the responsibilities, duties, and obligations as if such property
757 were recovered by the State Escheator.

758 (6) The Secretary of State may make such rules and regulations as deemed necessary to enforce this section.

759 (b) The Secretary of State may request that a person enter into an unclaimed property voluntary disclosure
760 agreement to determine if the person has complied with any provision of this chapter. If the form indicating the person's
761 intent to enter into a voluntary disclosure agreement is not received by the Secretary of State by certified mail or by other
762 means deemed acceptable by the Secretary of State within 60 days after the request to enter the voluntary disclosure
763 agreement program was mailed by certified mail, the Secretary of State shall refer the person to the State Escheator for
764 examination under § 1175 of this title.

765 (c) With respect to a person who has indicated in writing the person's intent to enter into an unclaimed property
766 voluntary disclosure agreement under this chapter by completing, executing, and delivering to the Secretary of State a form
767 acceptable to the Secretary of State, the person shall complete a review of its books and records and file reports of property
768 related to the following years:

769 (1) Beginning January 1, 1996, with respect to any person who enters an unclaimed property voluntary
770 disclosure agreement and makes payment in full or enters into a payment plan no later than June 30, 2016.

771 (2) With respect to a person who enters an unclaimed property voluntary disclosure agreement and makes

772 payment in full on or after July 1, 2016, the person shall complete a review of the person's books and records starting
773 the first of January for the prior 10 years from when the property is presumed abandoned starting from the calendar
774 year in which the person's intent to enter into an unclaimed property voluntary disclosure agreement was accepted by
775 the Secretary of State.

776 (d) With respect to any person whose intent to enter into an unclaimed property voluntary disclosure agreement
777 was accepted by the Secretary of State after September 30, 2014, the person shall enter an unclaimed property voluntary
778 disclosure agreement and make payment in full or enter into a payment plan within 2 years from the date the person's intent
779 to enter into an unclaimed property voluntary disclosure agreement was accepted by the Secretary of State. The due date for
780 entering into an unclaimed property voluntary disclosure agreement and making payment in full or entering into a payment
781 plan may be amended by the Secretary of State.

782 (e) Notwithstanding any other provision of this section or of this chapter, the Secretary of State may not enter an
783 unclaimed property voluntary disclosure agreement with or otherwise receive or seek payment of any amounts of property
784 from any of the following:

785 (1) A person who has indicated in writing the person's intent to enter into an unclaimed property voluntary
786 disclosure agreement by completing, executing, and delivering, on or before June 30, 2012, the appropriate form
787 promulgated by the State Escheator. But, the Secretary of Finance and the Secretary of State may permit the person to
788 enter into the voluntary disclosure program administered by the Secretary of State under this section. If a person is
789 permitted to enter the program, the look back period for the voluntary disclosure under this section relates to the date
790 the original notice of intent to enter a voluntary disclosure was completed, executed, and delivered.

791 (2) A person who has entered a voluntary disclosure agreement with the State Escheator on or before June 30,
792 2012. But, the Secretary of State may enter an unclaimed property voluntary disclosure agreement with any person
793 with respect to property types or periods or both property types and periods that were not included in the voluntary
794 disclosure agreement executed prior to June 30, 2012, or with respect to the person, its subsidiaries, or related entities
795 that were not included in the voluntary disclosure agreement executed prior to June 30, 2012.

796 (3) A person to which a notice of examination has been mailed by the State Escheator, except those persons
797 that elect to enroll in the Secretary of State's unclaimed property voluntary disclosure program under § 1176(b) of this
798 title.

799 (4) A person who had previously enrolled in the Secretary of State's voluntary disclosure agreement program
800 and one of the following occurred:

801 a. The person formally withdrew from the voluntary disclosure agreement program.

802 b. The Secretary of State removed the person from the voluntary disclosure agreement program for failure
803 to work in good faith to complete the voluntary disclosure agreement program as soon as practicable.

804 (f) Each person described in paragraph (e)(1) or (e)(2) of this section shall be accorded the benefit of the same
805 look back periods established in subsection (c) of this section, but the State Escheator shall retain authority over all
806 voluntary disclosure agreements so described.

807 § 1178. Records obtained in examination.

808 All of the following apply to records obtained and records, including work papers, compiled by the State Escheator
809 in the course of conducting an examination under § 1175 of this title:

810 (1) The records are subject to the confidentiality and security provisions of § 1193 of this title and are not a
811 “public record” under Chapter 100 of Title 29.

812 (2) The records may be used by the State Escheator in an action to collect property or otherwise enforce this
813 chapter.

814 (3) The records may be used in a joint examination conducted with another state, the United States, a foreign
815 country or subordinate unit of a foreign country, or any other governmental entity if the other person conducting the
816 examination is legally bound to maintain the confidentiality and security of information obtained from a person subject
817 to examination in a manner substantially equivalent to § 1193 of this title.

818 (4) The records may be disclosed to the person that administers the unclaimed property law of another state
819 for that state’s use in circumstances equivalent to circumstances described in this chapter, if the other state is required
820 to maintain the confidentiality and security of information obtained in a manner substantially equivalent to § 1193 of
821 this title.

822 (5) The records must be produced by the State Escheator under an administrative or judicial subpoena or
823 administrative or court order.

824 (6) The records must be produced by the State Escheator on request of the person that is the subject of the
825 examination.

826 § 1179. Evidence of debt or undischarged obligation.

827 (a) A record showing an unpaid debt or undischarged obligation is prima facie evidence of an obligation. In
828 claiming property from a holder, the State Escheator’s burden of proof as to the existence and amount of the property and
829 its abandonment is satisfied by showing evidence of the unpaid debt or undischarged obligation and passage of the requisite
830 period of abandonment.

831 (b) A holder may overcome prima facie evidence under subsection (a) of this section by establishing by a

832 preponderance of the evidence that one of the following occurred:

833 (1) A check, draft, or similar instrument was issued as an unaccepted offer in settlement of an unliquidated
834 amount.

835 (2) A check, draft, or similar instrument was issued but later was replaced with another instrument because the
836 earlier instrument was lost or contained an error that was corrected.

837 (3) A check, draft, or similar instrument was issued to a party affiliated with the issuer.

838 (4) A check, draft, or similar instrument was paid, satisfied, or discharged.

839 (5) A check, draft, or similar instrument was issued in error.

840 (6) A check, draft, or similar instrument was issued without consideration.

841 § 1180. Failure of person examined to retain records.

842 (a) If a person subject to examination under § 1175 of this title does not retain the records required by § 1145 of
843 this title, the State Escheator may determine the amount of property due using a reasonable method of estimation based on
844 all information available to the State Escheator, including to extrapolation and the use of statistical sampling when
845 appropriate.

846 (b) The Secretary of Finance, in consultation with the Secretary of State, shall, on or before July 1, 2017,
847 promulgate regulations regarding the method of estimation to create consistency in any examination or voluntary
848 disclosure. These regulations must include permissible base periods, items to be excluded from the estimation calculation,
849 aging criteria for outstanding and voided checks, and the definition of what constitutes complete and researchable records.

850 § 1181. Report to person whose records were examined.

851 At the conclusion of an examination under § 1175 of this title, the State Escheator shall provide to a person whose
852 records were examined a complete and unredacted examination report, which must identify in detail all of the following:

853 (1) The property types reviewed.

854 (2) The methodology of any estimation technique, extrapolation, or statistical sampling method used in
855 conducting the examination.

856 (3) The calculation showing the value of property determined to be due.

857 (4) The findings of the person conducting the examination.

858 § 1182. State Escheator's contract with another to conduct compliance review and examination and limit on future
859 employment.

860 (a) The State Escheator may contract with a person to conduct compliance reviews and examinations in
861 accordance with this chapter but no such person shall be assigned more than 50% of the number of all such compliance

862 reviews and examinations undertaken subsequent to January 1, 2015.

863 (b) Notwithstanding any other provision of this Code, every contract between the State and a person conducting
864 examinations and providing any unclaimed property examination or consulting services must meet both of the following:

865 (1) Be for a term of no more than 5 years.

866 (2) Provide that the person may not hire, retain, or compensate in any way any employee of the Division of
867 Revenue or the Department of Finance who functions in a senior supervisory role related to unclaimed property,
868 including the Secretary of Finance, a Deputy Secretary of Finance, the State Escheator, or Audit Manager, for a period
869 of 2 years from the time such employee leaves the employ of the State.

870 § 1183. Judicial review procedure: Court of Chancery jurisdiction.

871 (a) If, after examining any report required by this chapter and filed by or on behalf of a holder or after the
872 conclusion of an examination of a holder, the State Escheator determines that a holder has underreported unclaimed
873 property due and owing under this chapter, the State Escheator shall mail a statement of findings and request for payment to
874 the holder that filed, or on whose behalf the report was filed, or that was the subject of an examination. Ninety days after
875 the date on which the State Escheator mails a statement of findings and request for payment, it shall constitute the State
876 Escheator's final determination of the amount of the holder's liability, including interest and penalties, if any, for the
877 unclaimed property specified in the statement of findings and request for payment.

878 (b) Not later than 90 days after the State Escheator mails a statement of findings, the holder may do any of the
879 following:

880 (1) File an action against the State Escheator in the Court of Chancery challenging the State Escheator's
881 determination of liability and seeking a declaration that the determination is unenforceable, in whole or in part.

882 (2) Pay the amount or deliver the property determined by the State Escheator to be paid or delivered to the
883 State Escheator and file an action against the State Escheator in the Court of Chancery for a refund of all or part of the
884 amount paid or return of all or part of the property delivered.

885 (c) If the holder pays or delivers property the State Escheator determined must be paid or delivered to the State
886 Escheator at any time after the holder files an action under paragraph (b)(1) of this section, the Court of Chancery shall
887 continue the action as if it had been filed originally as an action for a refund or return of property under paragraph (b)(2) of
888 this section.

889 (d) In the appeal to the Court of Chancery, the Court, when factual determinations are at issue, shall take due
890 account of the experience and specialized competence of the State Escheator and of the purposes of the basic law under
891 which the State Escheator has acted. The Court's review shall be limited to a determination of whether the statement of

892 findings and request for payment was the product of an orderly and logical deductive process rationally supported by
893 substantial, competent evidence on the hearing record. The Court shall review errors of law de novo, and the Court's review
894 shall include state or federal constitutional questions related to the examination. If the Court determines that the statement
895 of findings is insufficient for its review, it shall remand to the State Escheator for further proceedings.

896 (e) When a determination under § 1183 of this title becomes final and is not subject to judicial review, the State
897 Escheator may commence an action in the Court of Chancery or in an appropriate court of another state to enforce the
898 determination and secure payment or delivery of past due, unpaid, or undelivered property.

899 § 1184. Judicial action to enforce liability.

900 (a) If any person refuses to pay or deliver property, including penalty or interest on the property, to the State
901 Escheator as required by this chapter, the State Escheator may bring an action to enforce such payment or delivery in the
902 Court of Chancery in the county in which the holder resides or has a principal place of business or, if no such principal
903 place of business exists, in New Castle County.

904 (b) In an action under subsection (a) of this section, if no court in this State has jurisdiction over the defendant, the
905 State Escheator may commence an action in a federal court or state court having jurisdiction over the defendant.

906 § 1185. Interstate agreement and cooperation.

907 (a) Subject to subsection (b) of this section, the State Escheator may do both of the following:

908 (1) Exchange information with another state relating to property presumed abandoned or relating to the
909 possible existence of property presumed abandoned.

910 (2) Authorize in a record another state or foreign country or a person acting on behalf of the other state or
911 country to examine its records of a holder as provided in § 1175 of this title.

912 (b) An exchange of information or examination of records under subsection (a) of this section may be done only if
913 the other state has confidentiality and security requirements substantially equivalent to those in § 1193 of this title or agrees
914 in a record to be bound by this State's confidentiality and security requirements.

915 § 1186. Action involving another state.

916 (a) The State Escheator may join other states to examine and seek enforcement of this chapter against any person
917 believed to be holding property reportable under this chapter.

918 (b) On request of another state, the Attorney General may commence an action on behalf of the other state to
919 enforce, in this State, the law of the other state against a holder of property presumed abandoned and therefore subject to a
920 claim by the other state, if the other state agrees to pay costs incurred by the Attorney General in the action.

921 (c) The State Escheator may request the official authorized to enforce the unclaimed property law of another state

922 to commence an action to recover property in the other state on behalf of the State Escheator. This State shall pay all costs,
923 including reasonable attorney's fees and expenses, incurred by the other state in an action under this subsection.

924 (d) The State Escheator may pursue an action on behalf of this State to recover property subject to this chapter but
925 delivered to the custody of another state if the State Escheator believes the property is subject to the custody of the State
926 Escheator.

927 (e) The State Escheator may retain a private attorney in this State or another state or foreign country to commence
928 an action to recover property on behalf of the State Escheator and may agree to pay attorney's fees based in whole or in part
929 on a fixed fee, hourly fee, or a percentage of the amount or value of property recovered in the action.

930 (f) Expenses incurred by this State in an action under this section may be paid from property received under this
931 chapter or net proceeds of the property. Expenses paid to recover property may not be deducted from the amount that is
932 subject to a claim under this chapter by the owner.

933 § 1187. Interest and penalties.

934 (a) Interest at 0.5% per month on outstanding unpaid amounts accrues from the date the amounts or property were
935 due under this chapter until paid. Interest due in accordance with this subsection may not exceed 50% of the amount
936 required to be paid. Penalties under subsections (b), (c), or (d) of this section are not interest for purposes of this subsection.
937 This subsection applies to any late-filed unclaimed property that is reported and remitted on or after July 1, 2017.

938 (1) Under § 1177 of this title, the Secretary of State possesses the authority to waive interest under this section
939 on outstanding unpaid amounts reported through the Secretary of State's voluntary disclosure program.

940 (2) Interest is waived for any holder who has filed the holder's intent in accordance with § 1176(c) of this title
941 to enter a Department of Finance expedited examination process on or before July 1, 2017, if the holder acts in good
942 faith to complete the examination.

943 (b) If a person fails to file any report required by this chapter on or before the due date prescribed for the report,
944 determined with regard to any extension of time for filing, unless it is shown that such failure is due to reasonable cause
945 and not willful neglect, the person shall add to the amount of unclaimed property required to be shown on the report the
946 lesser of 5% of the amount thereof if the failure is not for more than 1 month, with an additional 5% for each additional
947 month or fraction thereof during which such failure continues, not to exceed 50% in the aggregate or a civil penalty of \$100
948 for each day the report is withheld or the duty is not performed, but not more than \$5,000.

949 (c) If a person fails to pay the amount of unclaimed property required to be shown on any report required by this
950 chapter on or before the due date prescribed for the payment of such property, determined with regard to any extension of
951 time for payment, unless it is shown that such failure is due to reasonable cause and not willful neglect, the person shall add

952 to the amount of such property required to be shown on any report 0.5% of the amount of such property if the failure is for
953 not more than 1 month, with an additional 0.5% for each additional month or fraction thereof during which such failure
954 continues, not to exceed 25% in the aggregate. For purposes of this subsection, the amount of property shown on any report
955 is to be reduced by the amount of any property which is paid on or before the beginning of the month for which a
956 calculation is made under this subsection.

957 (d) If any part of a deficiency in payment of unclaimed property required to be shown on any report is due to
958 fraud, the person must add to the property required to be shown on the report an amount equal to 75% of the portion of the
959 deficiency in payment which is attributable to fraud. The penalty prescribed by this subsection applies only in cases where a
960 report of unclaimed property is filed and only to that part of the deficiency in payment the State Escheator establishes is due
961 to fraud or willful misrepresentation

962 § 1188. Other civil penalties.

963 (a) If a holder enters into a contract or other arrangement for the purpose of evading an obligation under this
964 chapter or otherwise willfully fails to perform a duty imposed on the holder under this chapter, the State Escheator may
965 require the holder to pay the State Escheator, in addition to interest as provided in § 1187(a) of this title, a civil penalty of
966 \$1,000 for each day the obligation is evaded or the duty is not performed, up to a cumulative maximum amount of \$25,000,
967 plus 25% of the amount or value of any property that should have been but was not reported, paid, or delivered as a result
968 of the evasion or failure to perform.

969 § 1189. Waiver of interest and penalty.

970 (a) The State Escheator may, for good cause, waive, in whole or in part, penalties under §§ 1187 or 1188 of this
971 title.

972 (b) The State Escheator may, for good cause, waive up to 50% of the calculable interest under § 1187 of this title.

973 § 1190. When agreement to locate property enforceable.

974 An agreement by an owner and a person, the primary purpose of which is to locate, deliver, recover, or assist in the
975 location, delivery, or recovery of property held by the State Escheator, is enforceable only if the agreement meets all of the
976 following criteria:

977 (1) It is in a record that clearly sets forth the nature of the property and the services to be provided.

978 (2) It is signed by or on behalf of the owner, with signature notarized.

979 (3) It states the amount or value of the property reasonably estimated or expected to be recovered computed
980 both before and after a fee or other compensation to be paid to the other person has been deducted.

981 (4) It discloses that the property is being held by the Department of Finance.

982 § 1191. When agreement to locate property unenforceable.

983 (a) Subject to subsection (b) of this section, an agreement under § 1190 of this title is void and unenforceable if it
984 is entered into during the period beginning on the date the property was distributable to the owner and ending 24 months
985 after the payment or delivery.

986 (b) If a provision in an agreement described in subsection (a) of this section applies to mineral proceeds for which
987 compensation is to be paid to the other person based in whole or in part on a portion of the underlying minerals or mineral
988 proceeds not then presumed abandoned, the provision is void and unenforceable regardless of when the agreement is
989 entered into.

990 (c) For an agreement under subsection (a) of this section, total fees and costs may not exceed \$1,000 or 10% of the
991 value of the property recovered, whichever is less.

992 (d) An owner or the State Escheator may assert that an agreement described in this section is invalid on a ground
993 other than it provides for payment of unconscionable compensation.

994 (e) This section does not apply to an owner's agreement with an attorney to contest the State Escheator's denial of
995 a claim for recovery of the property.

996 § 1192. Right of owner's agent to recover property held by State Escheator.

997 (a) An owner that contracts with a person to locate, deliver, recover, or assist in the location, delivery, or recovery
998 of property of the owner that is held by the State Escheator may appoint or designate the person as the owner's agent. The
999 appointment or designation must be in a record signed by the owner.

1000 (b) An owner's agent is entitled to receive from the State Escheator all information concerning the property which
1001 the owner would be entitled to receive, including information that would otherwise be confidential information under §
1002 1193 of this title.

1003 (c) If authorized by the owner, the owner's agent may bring an action against the State Escheator on behalf of and
1004 in the name of the owner.

1005 § 1193. Confidentiality of records.

1006 (a) Except in accordance with proper judicial order or as otherwise provided by law, it shall be unlawful for any
1007 officer or employee of the Department of Finance or the Department of State or for any other officer or employee of this
1008 State to disclose or make known in any manner to any person who is not a current officer or employee of this State any of
1009 the following:

1010 (1) The amount of unclaimed property that has been reported to and received by the State Escheator or the
1011 Secretary of State, or both, by any holder, under this chapter, or to disclose the terms of or supporting documentation

1012 related to any annual filing, unclaimed property voluntary disclosure agreement, or settlement agreement resulting
1013 from the reporting of any unclaimed property under this chapter, including all agreements entered into under this
1014 chapter, including past agreements.

1015 (2) Identifying information regarding any unclaimed property owner that is set forth in any report or record

1022 (1) The State Escheator shall retain other identifying information in a report or record made or delivered to the

1024 (2) The State Escheator shall consider the information in paragraph (b)(1) of this section to be confidential
1025 and the information may be disclosed only in the discretion of the State Escheator.

1026 (3) The State Escheator may provide additional information regarding unclaimed property as follows:

1027 a. To a person who has presented satisfactory proof of an interest in or title to such property.

1035 If any provision of this chapter or its application to any person or circumstance is held invalid, the invalidity does

SYNOPSIS

This Act continues the reforms enacted over the past 4 years by restructuring Chapter 11 of Title 12, and adopting in substance many provisions from the 2016 Revised Uniform Unclaimed Property Act promulgated by the Uniform Law Commission. In addition, this Act adopts certain recommendations from the Delaware Unclaimed Property Task Force formed under Senate Concurrent Resolution No. 59 of the 147th General Assembly, and makes significant changes to the State's unclaimed property law to bring greater predictability, efficiency, and fairness to the State's unclaimed property reporting process and compliance initiatives.

More specifically, these changes include reducing the look-back period of all voluntary disclosure agreements and audits to 10 report years, and creating a 10 year statute of limitations for the State to seek payment of unclaimed property due to the State. In addition, this legislation aligns the State's record retention requirement for companies with the statute of limitations and look back period, which brings State law into conformity with a majority of other states.

This Act also offers any company currently under audit prior to July 22, 2015, the opportunity to convert their audit into a voluntary disclosure agreement by entering into the Secretary of State Voluntary Disclosure Agreement program. All companies who received a notice of examination and are currently under audit as of the effective date of this Act will have the opportunity to engage in an expedited audit review process. Finally, this Act mandates that interest be assessed on any late-filed unclaimed property, as a means to incentivize voluntary compliance.
